

## 1. GENERAL PROVISIONS

The order form represents an agreement that binds signee to execution. By signing this contract, the participant confirms their participation in the event and accepts all terms, conditions, and deadlines of the organizer. The person signed confirms that she/he is authorized to represent the named company.

## 2. REGISTRATION

The registration should be made via Google form link on the official ICE website, as well as by signing the order form send to the participant. The organizer reserves the discretionary right to independently and finally decide on acceptance of each application and to inform the participant within 15 days of submission about possible rejection.

Registered participant has no authority to sublease his slot to other physical or legal entity and if he does so, shall be excluded from the event. The participant is entitled to present only his own yacht/fleet.

Due to its exclusivity and limited number of participants, registrations will be accepted as they come.

The registered participant confirms that all members who will participate at this event from the company will have a valid COVID-19 pass to present to the venue location official staff in Vienna or a negative PCR test. If the Austrian authorities implement new event regulations for the event dates, the organizer will require participants to follow Austrian regulations. The organizer is not responsible for covering costs of PCR tests for participants or other COVID-19 costs.

## 3. CANCELLATION OF PARTICIPATION

Cancellation terms apply from the moment of signing of the contract. The cancellation fee is 50% of list price from the moment of signing until November 8th, 2021. The cancellation fee is 100% of the listed price from November 8th, 2021. Cancellation must be made by the participant in written form. In case the participant is unable to travel to Vienna due to lock-down of the representatives' country, the organizer will issue a voucher in the paid amount. The organizer will not refund the amount paid. The voucher will then be used for the next ICE - Advent event, or other events organized by the organizer if requested by the participant, and if the organizer allows.

## 4. CHANGE OF DATES AND VENUE OF THE EXPO

Change of dates of the event, shortening, extension, temporary closure (partial or complete) or postponement due to unforeseen circumstances, does not imply the participant's right to indemnification from the organizer. In this case, the organizer is obliged to inform the participants promptly about the mentioned change but is not required to refund any amount. In case of complete cancelation of the event or postponement due to Covid Measures, the participant will receive a voucher which can be used for the next ICE - Advent edition or other events organized by the organizer if requested by the participant, and if the organizer allows.

## 5. INSURANCE

The organizer is not liable for any form of damage or loss of the property and equipment owned or leased by the participants, incurred due to negligence, theft, fire etc.

## 6. FINAL PROVISIONS

In case of dispute arising from non-compliance or different interpretation of the agreement, i.e. application form, the organizer and exhibitor agree that jurisdiction of the Courts in Zagreb shall apply.
